## DESIST AND REFRAIN ORDER

(For violations of section 25110, 25230 and 25401 of the Corporations Code)

The California Corporations Commissioner finds that:

- 1. At all relevant times, Denis Olds, was President of PMI Trading LLC an active California Corporation.
- 2. Beginning in or about February 2004 Dennis Olds, and PMI Trading LLC offered or sold securities in the State of California in the form of investment contracts representing limited partnership interests in a "PMI Capital Fund I L.P." through PMI Trading LLC.
- 3. Dennis Olds and PMI Trading LLC, offered or sold investment contracts representing interests in the "PMI Trading Fund I L.P." to California investors.

| 1  | 4. The offering was made to the public on the PMI Trading webpage, www.pmitradingllc.com            |

| 4  | 5. These securities were offered or sold in this state in issuer transactions. The Department of    |
| 5  | Corporations has not issued a permit or other form of qualification authorizing any person to offer |
| 6  | and sell these securities in this state.  |

| 8  | 6. Dennis Olds and PMI Trading LLC offered their services and acted as investment advisers          |
| 9  | from 2004 to the present.   |

| 11 | 7. Beginning in or about February 7, 2004 to the present, Dennis Olds and PMI Trading LLC,          |
| 12 | provided discretionary investment advice to one or more investors in connection with the business.  |

| 14 | 8. Dennis Olds and PMI Trading LLC, received compensation for the investment advisory               |
| 15 | services they provided to one or more investors in the amount of .75% of the average net assets,    |
| 16 | payable quarterly as "The Management Fee."  |
| 17 |   |
| 18 | 9. The Department of Corporations summarily revoked Dennis Olds' investment adviser license         |
| 19 | on February 6, 2004 for failure to pay the annual assessment and this license currently remains     |
| 20 | revoked. Therefore neither Dennis Olds nor PMI Trading LLC had a valid investment adviser           |
| 21 | certificate issued by the Department of Corporations or the U.S. Securities and Exchange            |
| 22 | Commission (SEC) from February 7, 2004 to the present.  |

| 24 | 10. In connection with these offers and sales, Dennis Olds and PMI Trading LLC, represented to      |
| 25 | investors that PMI Trading LLC is "licensed with the State of California and the SEC" when the      |
| 26 | company was not licensed with the state.  |

Based upon the foregoing findings, the California Corporations Commissioner is of the opinion that the investment contracts representing an interest in the PMI Capital Fund I L.P. are securities subject to qualification under the California Corporate Securities Law of 1968 and are being or have been offered or sold without being qualified in violation of Corporations Code section 25110. Pursuant to section 25532 of the Corporate Securities Law of 1968, Dennis Olds, PMI Trading LLC and PMI Capital Fund I L.P., are hereby ordered to desist and refrain from the further offer or sale in the State of California of securities, including but not limited to investment contracts, unless and until qualification has been made under the law.

Also, based upon the foregoing findings, the California Corporations Commissioner is of the opinion that Dennis Olds and PMI Trading LLC, have conducted business as investment advisers in this state without first applying for and securing from the commissioner a certificate authorizing them to do so, in violation of section 25230 of the Corporate Securities Law of 1968. Pursuant to section 25532(b) of the Corporate Securities Law of 1968, Dennis Olds and PMI Trading are hereby ordered to desist and refrain from acting as investment advisers in the State of California unless and until they have first applied for and secured from the Commissioner a certificate, then in effect, authorizing them to act as investment advisers.

Further, the California Corporations Commissioner is of the opinion that the securities representing interests in a "PMI Capital Fund I L.P." were offered or sold in this state by means of written or oral communications which included an untrue statement of a material fact or omitted to state a material fact necessary in order to make the statements made, in the light of the circumstances under which they were made, not misleading, in violation of section 25401 of the Corporate Securities Law of 1968. Pursuant to section 25532 of the Corporate Securities Law of 1968, Dennis Olds and PMI Trading LLC, are hereby ordered to desist and refrain from offering or selling any security in the State of California, including but not limited to investment contracts, by means of any written or oral communication which includes an untrue statement of a material fact or omits to state
