**DESIST AND REFRAIN ORDER AND CONSENT**  
(For violations of section 25110 of the Corporations Code)

Stan Snyder, Alexis Snyder, Robert Clyde Michael, SBG Forever, Inc. and Lands Alliance Information Services, Inc., consent to the jurisdiction of the Department of Corporations over their persons and over the subject matter of this proceeding. Further, Stan Snyder, Alexis Snyder, Robert Clyde Michael, SBG Forever, Inc. and Lands Alliance Information Services, Inc. consent to the entry of this Desist and Refrain Order and Consent, and the findings therein, made pursuant to California Corporations Code section 25110.

**Findings**

1. At all relevant times, SBG Forever, Inc., is and was a California corporation, incorporated on July 7, 1998. At all relevant times, Stan Snyder ("Mr. Snyder") and Alexis Snyder ("Mrs. Snyder") are and were control persons of SBG Forever, Inc.
2. At all relevant times, Lands Alliance Information Services, Inc. ("Lands Alliance"), is and was a California corporation, incorporated on August 12, 1999. The company maintains its principal place of business at 1040 S. Mt. Vernon Avenue, Suite G362, Colton, CA 92324. Records filed with the California Secretary of State indicate that Robert Clyde Michael is the President of Lands Alliance, however, Mr. Snyder and Mrs. Snyder are the true control persons of the company.

1 3. At all relevant times, Robert Clyde Michael ("Mr. Michael") is and was licensed by the  
2 California Department of Real Estate as a Mineral, Oil, and Gas Broker (License # 00948898) and the  
3 Board for Geologists and Geophysicists as a Geologist (License # 3849). Mr. Michael is an  
4 employee of Mr. Snyder and Mrs. Snyder.

5  
6 4. The Department of Corporations finds that beginning in or about August 1999, Mr. Snyder,  
7 Mrs. Snyder, Mr. Michael, SBG Forever, Inc. and Lands Alliance offered or sold securities in the  
8 form of investment contracts.

9  
10 5. The Department of Corporations finds that through general solicitations in the form of a Web  
11 site at [www.landslottery.com](http://www.landslottery.com), Mr. Snyder, Mrs. Snyder, Mr. Michael, SBG Forever, Inc. and Lands  
12 Alliance offered or sold securities to California residents.

13  
14 6. According to the Web site, [www.landslottery.com](http://www.landslottery.com), Mr. Snyder, Mrs. Snyder, Mr. Michael,  
15 SBG Forever, Inc. and Lands Alliance offer their "services" in exchange for a fee to assist investors  
16 in securing and maintaining an oil and gas lease, on a parcel of land, from the United States  
17 government. These services include geological evaluations of parcels of land, preparing and filing  
18 the necessary documents with the United States Government, and maintaining leases on behalf of  
19 investors. The object of acquiring a lease is to sell or assign the lease to an oil company, which will  
20 allegedly pay investors a sizable bonus and royalty payments for oil or gas recovered from the parcel.

21  
22 7. The Department of Corporations finds that these securities were offered and sold in the State  
23 of California in issuer transactions. The Department of Corporations has not issued a permit or other  
24 form of qualification authorizing any person to offer and sell these securities in this state.

25  
26 Based upon the foregoing findings and pursuant to section 25532 of the Corporate Securities  
27 Law of 1968 (California Corporations Code, § 25000 et seq.), Stan Snyder, Alexis Snyder, Robert  
28 Clyde Michael, SBG Forever, Inc. and Lands Alliance Information Services, Inc. are hereby ordered,

1 and each of them consents and agrees, to desist and refrain from the further offer or sale in the State of  
2 California of securities, including but not limited to investment contracts, unless and until qualification  
3 has been made under the law, or unless exempt.  
4

5 In consideration of this Desist and Refrain Order and Consent, Stan Snyder, Alexis Snyder,  
6 Robert Clyde Michael, SBG Forever, Inc. and Lands Alliance Information Services, Inc., waive their  
7 right to a hearing on this matter, provided for by the Corporate Securities law of 1968 section 25532,  
8 subdivision (d). Further, Stan Snyder, Alexis Snyder, Robert Clyde Michael, SBG Forever, Inc. and  
9 Lands Alliance Information Services, Inc. waive any and all review by a court of law, including that  
10 provided by California Government Code section 11523 and California Code of Civil procedure  
11 section 1094.5.  
12

13 This Order is necessary, in the public interest, for the protection of investors and consistent  
14 with the purposes, policies, and provisions of the Corporate Securities Law of 1968.
