9 **DESIST AND REFRAIN ORDER**
10 **(For violations of section 25110 and 25401 of the Corporations Code)**

11 The California Corporations Commissioner finds that:

- 12 1. At all relevant times, Eureka Shalom Business Ventures, Inc. (Eureka) was a California
- 13 corporation with a business address of 1443 E. Washington Boulevard, California 91104.
- 14 2. At all relevant times, Carol A. Johnson was the President of Eureka.
- 15 3. Beginning in or about March 2005, Eureka and Carol A. Johnson offered or sold securities, in
- 16 the State of California in the form of membership interests in Eureka Shalom Business Ventures,
- 17 Inc.'s "Emergency Fast Cash Relief Aid Program."
- 18 4. These securities were offered or sold in this state in issuer transactions. The Department of
- 19 Corporations has not issued a permit or other form of qualification authorizing any person to offer or
- 20 sell these securities in this state.
- 21 5. In connection with these offers and sales, Eureka and Carol A. Johnson represented to
- 22 potential investors that a \$1,500.00 investment would yield a \$25,000.00 return in five months.
- 23 Investors did not receive a return at all on their investments.

24 Based upon the foregoing findings, the California Corporations Commissioner is of the
25 opinion that the membership interests in Eureka Shalom Business Ventures, Inc.'s "Emergency Fast
26 Cash Relief Aid Program" are securities subject to qualification under the California Corporate
27 Securities Law of 1968 and are being or have been offered or sold without being qualified in
28 violation of Corporations Code section 25110. Pursuant to section 25532 of the Corporate Securities
Law of 1968, Eureka Shalom Business Ventures, Inc. and Carol A. Johnson are hereby ordered to

1 desist and refrain from the further offer or sale of securities in the State of California, including but
2 not limited to membership interests in Eureka Shalom Business Ventures, Inc.'s "Emergency Fast
3 Cash Relief Aid Program," unless and until qualification has been made under the law.

4 Further, the California Corporations Commissioner is of the opinion that the securities
5 representing membership interests in Eureka Shalom Business Ventures, Inc.'s "Emergency Fast
6 Cash Relief Aid Program were offered or sold in this state by means of written or oral
7 communications which included an untrue statement of a material fact or omitted to state a material
8 fact necessary in order to make the statements made, in the light of the circumstances under which
9 they were made, not misleading, in violation of section 25401 of the Corporate Securities Law of
10 1968. Pursuant to section 25532 of the Corporate Securities Law of 1968, Eureka Shalom Business
11 Ventures, Inc. and Carol A. Johnson are hereby ordered to desist and refrain from offering or selling
12 or buying or offering to buy any security in the State of California, including but not limited to
13 membership interests in high yield programs, by means of any written or oral communication which
14 includes an untrue statement of a material fact or omits to state a material fact necessary in order to
15 make the statements made, in the light of the circumstances under which they were made, not
16 misleading.

17 This Order is necessary, in the public interest, for the protection of investors and consistent
18 with the purposes, policies, and provisions of the Corporate Securities Law of 1968. This order shall
19 remain in full force and effect until further order of the California Corporations Commissioner.
