Corporations Code section 31115 provides, in relevant part:

The commissioner may summarily issue a stop order denying the effectiveness of or suspending or revoking effectiveness of any registration if the commissioner finds:

(a) That there has been a failure to comply with any of the provisions of this law or the rules of the commissioner pertaining thereto.

...

Based upon the findings in the Citation, which are incorporated herein by reference, the Commissioner is of the opinion that Amada failed to comply with Corporations Code sections 31123 and 31200.

For these reasons, the Commissioner of Business Oversight has determined that an order should be issued pursuant to Corporations Code section 31115, subdivision (a) denying the effectiveness of the renewal registration application submitted by Amada Franchise, Inc. on April 20, 2015.
