1 IT IS ORDERED that, subject to the Commissioner’s satisfactory review, the Petition for  
2 Reinstatement is granted provided that the following conditions are met by Petitioner within 45 days  
3 of the date hereof:

4 1. Submit a declaration to the Commissioner attesting under penalty of perjury that  
5 Petitioner has not made any loans subject to the CFLL during the period of September 26, 2011 to the  
6 date of this order.

7 2. For failure to report a current list of officers and directors as required by Financial  
8 Code section 22105, submit penalties in the amount of \$2,500.00 payable to the “Department of  
9 Business Oversight” and mailed to the attention of Miranda LeKander, Senior Counsel, 1515 K  
10 Street, Suite 200, Sacramento, California, 95814.

11 3. For failure to maintain a surety bond as required by Financial Code section 22112,  
12 submit penalties in the amount of \$2,500.00 payable to the “Department of Business Oversight” and  
13 mailed to the attention of Miranda LeKander, Senior Counsel, 1515 K Street, Suite 200, Sacramento,  
14 California, 95814.

15 4. Obtain fingerprint clearance from the Commissioner for all current officers and  
16 directors.
