26 reinstatement of its California Finance Lender Law license, which was revoked by the Commissioner
27 of Business Oversight (“Commissioner”) on January 27, 2009, the petition has been considered, no
28 further argument submitted, and good cause appearing,

1 IT IS ORDERED that, subject to the Commissioner’s satisfactory review, the Petition for
2 Reinstatement is granted provided that the following conditions are met by Bridgefund within 30
3 days (30) of the date hereof:

4 1) Submission of a financial statement in the form of a balance sheet, prepared in
5 accordance to generally accepted accounting principles, and as evidence of compliance under
6 Financial Code Section 22104.

7 2) Payment of penalties to the Department of Business Oversight (“Department”) in the
8 amount of \$2,500.00 for failure to maintain a surety bond, attention to: Vanessa T. Lu, Enforcement
9 Division, Department of Business Oversight, 320 West 4th Street, Suite 750, Los Angeles, California
10 90013.

11 3) Bridgefund must seek written permission and receive approval from the Department
12 before using the entity “EZ Cash” to conduct any California Finance Lender activity.
