The petition having been considered, no further argument having been submitted, and good cause appearing,

IT IS ORDERED that, subject to the Commissioner’s satisfactory review, the Petition for Reinstatement is granted provided that within thirty days of the date hereof, unless otherwise indicated below, Coast to Coast Lending Group, Inc. does the following:

- 1. Pay a penalty in the amount of \$2,500.00 for failing to timely pay the 2010-2011 annual assessment, in violation of California Financial Code section 22107; and
- 2. Pay a penalty in the amount of \$500.00 for failing to timely notify the Commissioner of Petitioner’s change of address, in violation of California Financial Code section 22153.

Payment of the above penalties shall be made payable in the form of a cashier’s check to the “Department of Business Oversight,” and mailed to the attention of Affi Eghbaldari, Counsel, Enforcement Division, at the Department of Business Oversight located at 1350 Front Street, Room 2034, San Diego, California, 92101.
