Under Government Code section 11522, the Attorney General is hereby notified that on or around April 6, 2017, Sean Roberts a.k.a. Sean R. Roberts (Petitioner) filed with the Commissioner

1 of Business Oversight (Commissioner) a petition for reinstatement of his California Financing Law<sup>1</sup>
