The California Corporations Commissioner ("Commissioner") finds that:

26 Acceptance Capital Mortgage Corporation has failed to maintain its financial statements on a  
27 current basis, failed to conduct its bank reconciliations on a monthly basis, and failed to timely  
28 provide the Commissioner with its financial records such that it would properly enable the

1 Commissioner to determine whether Acceptance Capital Mortgage Corporation is performing  
2 residential mortgage lending functions in compliance with the provisions of the California  
3 Residential Mortgage Lending Act (Fin. Code, § 50000, et seq.) and the rules promulgated thereunder  
4 in violation of California Financial Code section 50314 and California Code of Regulations, title 10,  
5 section 1950.314.2.

6 NOW, BASED UPON THE FOREGOING, AND GOOD CAUSE APPEARING, it is hereby  
7 ORDERED under the provisions of California Financial Code section 50321, that Acceptance Capital  
8 Mortgage Corporation immediately discontinue the violations set forth above.
