**[PROPOSED] JUDGMENT BY COURT AFTER DEFAULT**

1. On March 30, 2011, Plaintiff, the California Corporations Commissioner, filed her Complaint against Defendants Pursol Solar Systems, Inc. and Vince Aguon for violation of Corporations Code section 25110 and violation of a Desist and Refrain Order issued by the Commissioner.

2. The Complaint seeks injunctive relief prohibiting Defendants from violating Corporations Code section 25110 and the Desist and Refrain Order; restitution to Defendants' victims residing in California in the amount of at least \$605,201.00; and civil penalties of at least \$2,300,000.00.

3. The Complaint was served on Defendants.

1           4.       On March 9, 2012, this Court ordered that the answer of Defendant Pursol Solar  
2 Systems, Inc. be stricken.

3           5.       On April 12, 2012, the court clerk entered the default of Defendant Pursol Solar  
4 Systems, Inc.

5           6.       On July 20, 2012, this Court ordered that the answer of Defendant Vince Aguon be  
6 stricken.

7           7.       On July 23, 2012, the court clerk entered the default of Defendant Vince Aguon.

8           GOOD CAUSE APPEARING THEREFORE, IT IS HEREBY ADJUDGED, ORDERED  
9 AND DECREED THAT JUDGMENT BE ENTERED AS FOLLOWS:

10                   **I.       INJUNCTIVE RELIEF**

11           DEFENDANTS and their agents, employees, attorneys in fact in their capacities as such,  
12 and all persons acting in concert or participating with them, shall be and are hereby permanently  
13 enjoined from directly or indirectly:

14           1.       Violating California Corporations Code section 25110 by offering to sell, selling,  
15 arranging for the sale of, issuing, engaging in the business of selling, or negotiating for the sale of  
16 and security of any kind, unless such security or transaction is qualified;

17           2.       Violating the Desist and Refrain Order issued by the California Corporations  
18 Commissioner on March 24, 2010, by offering and selling unqualified, non-exempt securities in  
19 violation of California Corporations Code section 25110;

20                   **II.       RESCISSION AND RESTITUTION**

21           DEFENDANTS are hereby ordered, jointly and severally, to rescind each and all of the  
22 unlawful transactions alleged in the Complaint, and to pay full restitution to each California  
23 resident who was subject to Defendants' acts or practices which constitute violations of the  
24 Corporate Securities Law of 1968, as follows:
