25 Pursuant to Government Code Section 11522, you are hereby notified that on April 2, 2009,  
26 Respondent, Gina Simnowski (“Simnowski”) filed a Petition for Reinstatement or Reduction of  
27 Penalty (“Petition”) with the California Corporations Commissioner (“Commissioner”). The  
28 Commissioner is considering the Petition even though it was filed eleven (11) days earlier than

1 allowed by law. A true and correct copy of the Petition is attached hereto and incorporated herein as  
2 Exhibit 1.

3 On June 18, 2002, the Commissioner issued an Order barring Simnowski from any position  
4 of employment, management or control of any escrow agent, effective April 12, 2002. This Order  
5 was issued pursuant to a proposed decision issued by Administrative Law Judge Jonathan Lew on  
6 March 13, 2002, which was adopted and made effective by the Commissioner on April 12, 2002  
7 (“Decision”). A true and correct copy of the Decision is attached and incorporated herein as Exhibit  
8 2.

9 YOU ARE FURTHER NOTIFIED that written argument may be presented in this matter and  
10 should be received by the Department of Corporations **on or before June 29, 2009** at its office  
11 located at 320 West 4<sup>th</sup> Street, Ste. 750, Los Angeles, California 90013-1105, attention: Judy L.  
12 Hartley, Senior Corporations Counsel.

13 The Commissioner shall render a decision in this matter on or before July 30, 2009.
