 25 Pursuant to Government Code Section 11522, you are hereby notified that on July 21, 2010,  
 26 Respondent, Gina Simnowski (“Simnowski”) filed a Petition for Reinstatement or Reduction of  
 27 Penalty (“Petition”) with the California Corporations Commissioner (“Commissioner”). A true and  
 28 correct copy of the Petition is attached hereto and incorporated herein as Exhibit 1.

1           On June 18, 2002, the Commissioner issued an Order barring Simnowski from any position  
2 of employment, management or control of any escrow agent, effective April 12, 2002. This Order  
3 was issued pursuant to a proposed decision issued by Administrative Law Judge Jonathan Lew on  
4 March 13, 2002, which was adopted and made effective by the Commissioner on April 12, 2002  
5 (“Decision”). A true and correct copy of the Decision is attached and incorporated herein as Exhibit  
6 2.

7           YOU ARE FURTHER NOTIFIED that written argument and/or documentation in support of  
8 the statements made in the Petition may be presented in this matter and should be received by the

11 Corporations Counsel.

12           The Commissioner shall render a decision in this matter on or before September 27, 2010.
