1 TO ALL PARTIES AND THEIR ATTORNEYS OF RECORD:

2 Judgment is entered permanently enjoining the Commissioner and agents acting
3 on behalf of the Commissioner from exercising visitorial powers over plaintiffs; further,
4 judgment is entered in favor of plaintiffs on their Supremacy Clause preemption claims under the
5 National Bank Act and its implementing regulations and in favor of the Commissioner on
6 plaintiffs' Depository Institutions Deregulation and Monetary Control Act of 1980, retaliation, 42
7 U.S.C. § 1983 and 42 U.S.C. § 1988 claims.
